 They can be divided into content, civil liability.

- List of content, with the aproximate
 Price or invoices.
- Your rental contract, a copy of it, if you are the owner you may have to present the registration of your house.
- The yearly payment goes around the value and it various from \$100 to \$150.00

CAR INSURANCE

- BRAND NEW CAR
- CARS IN PANAMA AFTER 8 YEARS OLD, most of the Insurance Company will not give full coverage, we might get one or two companies that will do so, but after an inspection.

- FULL COVERAGE:
- BODY INJURY.....100k
- DAMAGE TO HARBOR PROPERTY...300k
- MEDICAL ASSISTANCE....10k ... PER PERSON (PER SEAT)
- COLLISION AND SPILL (VALUE OF THE CAR)
- COMPREHENSIVE(VALUE OF THE CAR)
- ► FIRE (VALUE OF THE CAR)
- STOLE (VALUE OF THE CAR)
- ACCIDENTAL DEATH....2K PER, PERSON IN THE CAR.

CARS AFTER 8 OR TEN YEARS OLD

- Third party
- Third party provides the lowest level of car insurance cover. It insures you against damage to another person's car or injury to them, however it doesn't cover your car should it need to be repaired or replaced.

FOR USA EXPAT

- Even if no assistance is needed in making funeral arrangements, the death of an American citizen, whether resident or tourist in Panama, should be reported to the ACS Unit so that a Report of Death of an American Citizen Abroad can be issued. This document is usually necessary to settle legal and estate matters in the United States. The Report provides the essential facts concerning the death of a U.S. citizen and is based on the Panamanian death certificate.
